

END-USER LICENSE AGREEMENT (EULA) FOR "Highlight This!"
IMPORTANT: PLEASE READ THIS EULA CAREFULLY BEFORE USING THE "Highlight This!"
CHROME EXTENSION. BY INSTALLING OR USING THE SOFTWARE, YOU AGREE TO BE
BOUND BY THE TERMS AND CONDITIONS OF THIS EULA.

License Grant:

- a. Free Version: For the free version of the "Highlight This!" Chrome extension, the software developer ("Developer") grants you a non-exclusive, non-transferable license to use the Software without any time restrictions ("Free License").
- b. Paid Version: For the paid 1-year license of the "Highlight This!" Chrome extension, the Developer grants you a non-exclusive, non-transferable license to use the Software for a period of 1 year ("Paid License").
- c. These licenses are granted solely for your personal or internal business use and are subject to the terms and conditions of this EULA.

Permitted Use:

- a. You may install and use the Software on any compatible Chrome browser on a device owned or controlled by you.
- b. You may not sublicense, sell, distribute, rent, lease, or transfer the Software to any third party.
- c. You may not modify, reverse engineer, decompile, disassemble, or create derivative works based on the Software.

Intellectual Property Rights:

- a. The Software and any associated documentation are the intellectual property of the Developer and are protected by copyright laws and international treaties.
- b. You acknowledge that you do not acquire any ownership rights to the Software and agree not to remove or modify any copyright, trademark, or proprietary notices.

Limitations of Liability:

- a. The Software is provided "as is" without warranties of any kind, either expressed or implied, including but not limited to, merchantability, fitness for a particular purpose, or non-infringement.
- b. In no event shall the Developer be liable for any direct, indirect, incidental, special, or consequential damages arising out of or in connection with the use or performance of the Software.

Termination:

- a. Free Version: The Free License is effective until terminated by either party. The Developer may terminate the Free License at any time without notice.
- b. Paid Version: The Paid License is effective until the end of the 1-year License Term.
- c. The Developer may terminate either license if you breach any of the terms and conditions outlined in this EULA.
- d. Upon termination, you must cease using the Software and uninstall it from all devices.

Updates and Support:

- a. The Developer may provide updates, bug fixes, or new features for the Software during the License Term, at its sole discretion.
- b. Support services, if provided, will be available in accordance with the Developer's support policies.

Governing Law and Dispute Resolution:

- a. This EULA shall be governed by and construed in accordance with the laws of Belgium.
- b. Any disputes arising out of or in connection with this EULA shall be resolved through arbitration in accordance with the rules of the Court of Commerce in Brussels, Belgium.
